Item No. 6: Honorarium to be paid to Guest Faculty

The regular classes of Prarambh will be starting from the academic session 2014 onwards. Since, adequate faculty is not available in Prarambh, it is proposed that guest faculty may be permitted to be engaged on a part time basis as per UGC guidelines. The UGC guidelines dated 06thFebruary, 2010 is enclosed at **Annexure III(page____).** These guest faculties will be paid at the rate of Rs. 1000/- per lecture.

UGC guidelines provide for a maximum payment of Rs. 25,000/- p.m. per faculty, which may kindly be dispensed with in the present case due to acute shortage of teacher faculty.

Item No. 7: Working schedule of Prarambh.

It is proposed that Prarambh will function for six days a week and the working hours will be as under:-

- a) Summer timings (April to Oct):- 8.30 AM to 4.30 PM
- b) Winter timings (Nov to March):- 9.00 AM to 5.00 PM

Moreover, since Prarambh is affiliated to Central University of Haryana, Mahendergarh, the vacation period/ holidays will be the same as approved by the said university.

Item No. 8: Payment of staff deployed by HPPI for the period October, 2013.

The State Level School for Teacher Education, Jhajjar, Haryana has signed a MOU with HPPI which will be operational from the academic year 2014-15. The students have joined Prarambh in December 2013. As NCTE has given permission for starting the Integrated BA/B Com/BSc B Ed Course from the academic session 2014-15, the students who joinedPrarambh were admitted into a six monthsCertificate in Information Technology (CIT) programme of IGNOU. HPPI has deployed three of its staff from October 2013 to assist Prarambh in making the Institute functional and also for taking care of the needs of the students in the CIT course of IGNOU and orientating them for the innovative inputs of the four year integrated B.A./B.Sc./B.Com B.Ed. course ,as per the curriculum approved by the Central University of Haryana, Mahendergarh. Now HPPI has requested for the release of funds amounting to Rs. 7,11,000/- (Seven lacs eleven thousand only) vide its letter dated 03/02/2014, which is placed at Annexure IV (page____) for meeting the payment of salary, travel, insurance, training etc. of its faculty, deployed at Prarambh.

The proposal above of HPPI is submitted for approval please.

Since filling up of the vacant post will take time, the above mentioned work has been outsourced to M/s BVG on the following terms and conditions:-

- a) Basic minimum wages will be given to all the contractual employees as per rates notified by the Deputy Commissioner, Jhajjar.
- b) EPF inclusive of EDLI and ESI will be paid at rates fixed by the Govt. with a ceiling of Rs. 6500/-.
- c) Service tax will be paid as per rules.
- d) The service charges (management fee) will not be paid to the firm as of now. This will be claimed as arrears after the finalization of tender, which has been issued by the institute, at the lowest rate quoted by the L-I firm.

The Institute has also issued a tender for outsourcing the work and bids have been received. Finalisation of the tender will take time. Hence, it is requested that the allotment of work to M/s BVG may please be approved as proposed above.

Item No. 10: Re-employment of Sh. Rajbir Singh, Assistant

Due to shortage of trained staff in Prarambh, Sh. Rajbir Singh, Assistant retired from the office of District Education Officer, Jhajjar in the month of December 2013, has been engaged, on the contractual basis w.e.f 13/01/2014. As per Haryana Govt. rules, it is proposed to fix his emoluments as under:-

"The basic pay of the officer shall be the amount as drawn by him as pay at the time of retirement minus Pension and Pension equivalent to Gratuity reduced to the nearest round figure as applicable to the case of reemployment of a Government Employee after retirement as per relevant rules. In addition, Dearness allowance as admissible from time to time is also given."

It is requested that the engagement of Sh. Rajbir Singh as Assistant on the above mentioned terms and conditions may kindly be approved.

Item No. 11: Creation of the post of Laboratory Assistant for the various labs.

From the academic session 2014, Prarambh will start its regular classes for the integrated B.A./B.Sc./B.Com B.Ed. course. Subjects like Physics, Chemistry, Maths, Botany, Zoology, Psychology, Computer and Geography will require setting up of laboratory. It is requested that for the present, 08 posts of Lab Assistant in the pay scale 5200-20200 with grade pay Rs. 1800/- may kindly be created as per details given below:-

Item no 15: Taking academic and administrative support from NCERT.

The Govt of Haryana has set up Prarambh-State Level School for Teacher Education, at Jhajjar, Haryana. NCTE has granted its approval for starting a four year Integrated BA/ B.Sc/ B.Com B.Ed Course from the academic session 2014-15. At present 40+ students have already taken admission and are presently undergoing a 6 months ICT certificate programme of IGNOU. The second admission test, for filling up vacant posts, was held in Feb. 2104,result of which is yet to be declared. The Institute has just taken its first step in the field of education and need to be nurtured properly, so as enableit to achieve its full potential. Since NCERT has rich experience of managing RIEs, a request has been made to NCERTfor providing full academic and administrative support to Prarambh, for the next five years. Further NCERT has also been requested to depute one of its facultiesfor the post of Principal of Prarambh. The Institute / Govt of Haryana undertakes to meet all the financial liabilities with respect to providing full academic and administrative support to the Institute and posting of a Principal (on deputation basis) in Prarambh. The proposal is submitted for approval, please.



- a) Basic minimum wages will be given to all the contractual employees as per rates notified by the Deputy Commissioner, Jhajjar.
- b) EPF inclusive of EDLI and ESI will be paid at rates fixed by the Govt. with a ceiling of Rs. 6500/-.
- c) Service tax will be paid as per rules.
- d) The service charges (management fee) will not be paid to the firm as of now. This will be claimed as arrears after the finalization of tender, which has been issued by the institute, at the lowest rate quoted by the L-I firm.

Further, the institute was directed to finalize the tender for outsourcing of work, at the earliest.

Item No. 10: Re-employment of Sh. Rajbir Singh, Assistant.

The Committee approved the re-employment of Sh. Rajbir Singh, who had retired as Assistant from the O/o DEO Jhajjar. His pay will be fixed as under:-

"The basic pay of the officer shall be the amount as drawn by him as pay at the time of retirement minus Pension and Pension equivalent to Gratuity reduced to the nearest round figure as applicable to the case of re-employment of a Government Employee after retirement as per relevant rules. In addition, Dearness allowance as admissible from time to time is also given."

Item No. 11:Creation of the post of Laboratory Assistant for the various labs.

The committee approved the proposal for creation of 08 posts of Laboratory Assistants for the various labs. It was further decided to take the approval of the Finance Department for the creation of the said posts.

Item No. 12:Creation of an additional post of Hostel Warden/Hostel Superintendent.

The committee approved the proposal for the creation of one more post of Hostel Warden/ Hostel Superintendent in PB-2 with pay scale 9300-34800 and grade

pay of 4200. The entry level pay will be as Rs. 12090/- + GP of Rs. 4200/-. It was further decided that the post of Hostel Warden for boys be got filled from amongst the retired Armed Force personnel's. Even in the case of Hostel Warden for Girls Hostel, preference will be given to retired Armed Force personnel's. Further, approval of Finance Department will be sought for the creation of post.

Item No. 14: Assigning duties of Dean Academics & Dean Students Welfare to the existing faculties.

For providing efficient and smooth administration and especially taking into the account the academics and the welfare of the students, the committee approved the proposal for assigning the duties of Dean Academics and Dean Students Welfare to the existing teaching faculty, on seniority-cum-merit basis.

Item No. 15: Taking academic and administrative support from NCERT.

The committee approved the proposal of taking academic and administrative from NCERT for a period of five years. Payment will be made to NCERT for the services provided by them. Further, the committee approved the appointment of Dr. Madhulika S. Patel, presently working as Associate Professor in NCERT, New Delhi, as Principal, Prarambh, on deputation basis, for a period of three years, on the usual terms and conditions. However, her existing remuneration and other benefits like transport allowance, medical allowance etc. as are admissible presently, will be protected as such. Further, she will be entitled for deputation allowance as per rules.
