

As per the MOU signed with HPPI, office staffs has been deployed by them to assist Prarambh in making the Institute functional and also for taking care of the needs of the students and orienting them for the innovative inputs of the 4 integrated course. Payment to the HPPI, for the period Oct. 2013-March 2014, has been approved in the 2nd meeting of the E.C. & will shortly be released. Now further payment from April, 2014 to Sept. 2014, amounting to Rs. 9,72000/-(Annexure-V) is to be made to HPPI, which is put up for approval of the E.C.

Item No. 6:

Affiliation of Prarambh with MDU.

Govt. of Haryana has set up Prarambh School for Teacher Education at Jhajjar, Haryana. The Central University of Haryana at Mahendergarh approved the course work for the four year Integrated Bachelor of Education Programme vide its letter dated 10.09.2012. National Council for Teacher Education vide its recognition order 16.09.2013 has granted recognition to Prarambh for conducting a B.A./B.Sc./B.Com B.Ed. (Secondary) and B.A./B.Sc./B.Com (Elementary) 4 years innovative courses. However Ministry of Human Resource Development, Govt. of India has conveyed vide its letter dated 25.02.2014 that it is not in agreement with the proposed ordinance of the Central University of Haryana under which recognition was granted to Prarambh School for Teacher Education, Jhajjar, Haryana. Meanwhile,

Prarambh went ahead and completed admission in the first year of the course and first semester examination is due.

In the given background, the State Govt. has now decided that the Institute be got affiliated with MDU Rohtak immediately to safeguard the interests of the students.
