1. The empanelment of Part-Time Faculty is till the end of the session 2025-26 or till an alternative arrangement is made, whichever is earlier. For subsequent sessions, the institute may decide to extend the same panel or may prepare a fresh panel.
2. The Institute reserves the right to adopt a rational criterion based on qualification, experience, expertise, demand in a particular subject, etc., to shortlist the candidates for placement on the panel.
3. Mere appearance of the name on a panel of experts in a particular subject does not guarantee engagement of experts. The institute will call only the suitable persons, subject to the availability of workload.
4. The remuneration will be paid on an hourly basis only with a ceiling per month. However, the candidates called as experts may be assigned some other ECA / CCA / Administrative duties in the institute without making any separate remuneration for that. Such experts may be engaged in university examination/evaluation or other duties as per requirements/norms.
5. Only the candidates attending the walk-in interview on the prescribed date and time will be considered for empanelment. No separate call letters / admit cards will be issued for the interview. However, the institute reserves the right to engage the experts at its own, outside the panel, in case of exigency of services required.
6. The empanelled experts will be liable to serve in any of the SIASTE as per the discretion of the authority.
